Toronto, Ontario, November 18, 2010 (TSX: CGX.UN): Cineplex Galaxy Income Fund announced today its cash distribution of \$0.105 per unit for the month of November 2010, payable on December 29, 2010, to unitholders of record on November 30, 2010.

Unitholders who are non-residents of Canada will be required to pay all withholding taxes payable in respect of any distributions of income by the Fund.
